Notice is hereby given that the State Water Resources Control Board (State Water Board) will be conducting public workshops to receive comment on how the State Water Board should proceed with the findings of the Storm Water Panel of Experts (Panel) that was convened to consider the following question:


Is it technically feasible to establish numeric effluent limitations, or some other objective criteria, for inclusion in storm water permits? How would such limitations or criteria be established, and what information and data would be required? The answer should address industrial general permits, construction general permits, and area-wide municipal permits. The answer should also address both technology-based limitations or criteria and water quality-based limitations or criteria. In evaluating establishment of any objective criteria, the panel should address all of the following: (1) the ability of the State Water Board to establish appropriate objective limitations or criteria; (2) how compliance determinations would be made; (3) the ability of dischargers and inspectors to monitor for compliance; and (4) the technical and financial ability of dischargers to comply with the limitations or criteria.

The Panel's response should address each of the types of permits (industrial, construction, and municipal).

The purpose of these workshops is to solicit comment from the public on how the State Water Board can use these findings to improve the National Pollutant Discharge Elimination System Storm Water program. The purpose of these workshops is to gather policy and technical input. The workshops are not being conducted as part of an adjudicative proceeding. Specific comments on the report or on specific upcoming permitting actions will not be allowed.
