Subject: SB 926-FLOREZ – BIOSOLIDS UPDATE

We anticipate SB 926 will be on the Senate Floor for vote next Thursday, May 12^{th.} While we understand Senator Florez is working hard to gain support for his bill, we are working just as hard to oppose it. CASA has prepared a Floor Alert for distribution to each of our 40 senators early next week. Your help is also needed.

We are requesting every member agency send an opposition letter to their Senator for delivery no later than Wednesday May 11th. Faxes followed by mailed copies are acceptable. A copy of the CASA Floor Alert along with a Senate fax directory is attached for your reference and use. The current bill language is provided below.

"40065. (a) Nothing in Section 13274 of the Water Code shall prohibit the Kern County Board of Supervisors, upon a majority vote, from regulating or prohibiting, by ordinance, the importation of sewage sludge from another California county for application to land within the jurisdiction of the county.

(b) A prohibition, if enacted pursuant to subdivision (a), shall provide an exemption for a contractual obligation to import sewage sludge for application to land that was in existence before the effective date of a prohibition. This subdivision shall not be construed as authorizing the exemption to apply to a renewal of a preexisting contractual obligation to import sewage sludge for application to land when the renewal occurs after the effective date of a prohibition.
(c) Nothing in this section supersedes other provisions of state or federal law, and nothing in this section affects the holding in County Sanitation Dist. No. 2 of Los Angeles County v. County of Kern, 127 Cal. App. 4th 1544, --- Cal. Rptr. 3d ----, 2005 WL 737528, 35 Envtl. L. Rep. 20,070, 5 Cal. Daily Op. Serv. 2907, 2005 Daily Journal D.A.R. 3974 (5th Dist., Apr 01, 2005)."

<u>SB 926 – FLOREZ – SEWAGE SLUDGE MANAGEMENT</u>

<u>OPPOSE</u>

Dear Senator Aanestad:

The undersigned local government agencies remain opposed to SB 926-Florez, as amended May 3, 2005. SB 926 would establish a special provision in law for Kern County only, relating to sewage sludge (biosolids) management.

The intent of SB 926 appears to be to provide special authority to Kern County that is beyond the authority enjoyed by other counties in the state. We feel this is an unacceptable precedent. Further, the legislative findings contained in the measure are inaccurate and misleading. Additionally, the bill severely undermines the concept of biosolids recycling, which is essential if California is to beneficially reuse biosolids in a manner similar to what is being done in other progressive regions of the nation.

SB 926 ignores the inter-reliance of counties on one another. Biosolids are beneficially used in Kern County because Kern County has arid land that can be turned into useful agricultural land, producing crops, such as alfalfa, milo and winter wheat for cattle feed. Just as cities in the Los Angeles and Ventura County areas rely on Kern County, likewise Kern County relies on cities like Oxnard to manage hazardous and other wastes, because Kern does not have the facilities needed to do so. (For example, oil brine wastes, high in salt, pass through Oxnard's wastewater treatment plant to the ocean where they are easily absorbed.) If Kern County can prohibit the importation of a recyclable material such as biosolids, what other county-by-county restrictions will follow?

Lastly, SB 926 would have a drastic impact on the entities that currently landapply biosolids to approximately 1% of the agricultural land in Kern County, likely leaving no other alternative but landfill disposal, particularly in the short-term.
