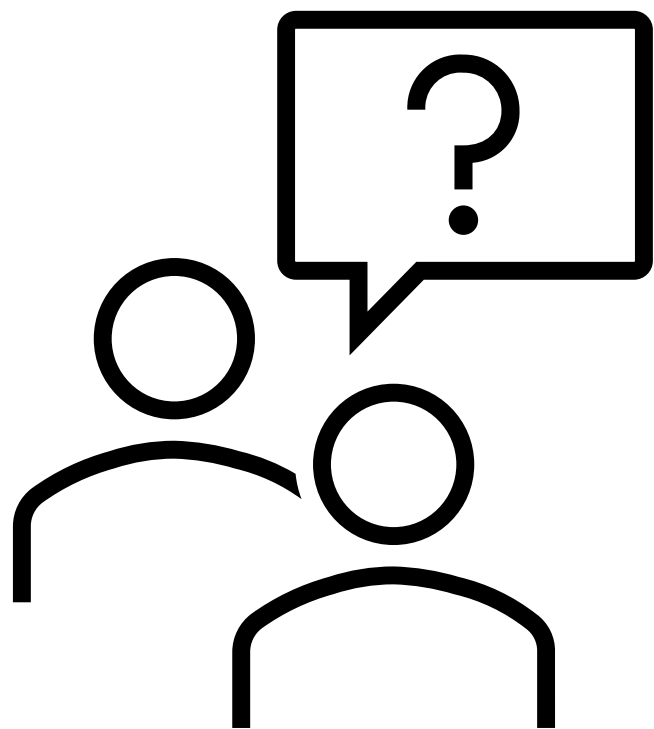

Priorities & Events:

Exfiltration (San Diego River Investigative Order)

- Identify and quantify relative contributions of suspected source of human fecal material in wet weather discharges to the San Diego River.
- Determine the transport pathways of such discharges.
- Determine how this information will be used by each Discharger to assess the effectiveness of current management measures in preventing discharge of human fecal matter into the San Diego River.
