

When was it first discovered?

- Date first observed:
 - June 1 2015 on Borla Place off Cadencia Street.



How was it found?

- Hydro-Cleaning PVC section on Borla Place
- Vactor nozzle stuck on its return
- Multiple pieces of "unknown" material protruding into manhole
- Removed and collected "unknown" substance
 - blue in color
 - smelled like cement

How was it found? (continued)

- Noticed contractor crew working on backyard hardscape at 7314 Borla Place
- Scope of work included a pool
- Questioned the contractor and informed him what was found
- Explained the importance of not disposing of any material into the collection system

What actions have been taken to identify the substance?

- Reached out to SCAP for agencies with similar situations
- Lab test to:
 - EWA
 - Test American Lab
- Inquiries were also made to local pool contractors and pool supply companies.

Results of investigation

SCAP survey results:

"I believe this is pool plaster as we spent several days cleaning this from a portion of our system last year. It looks very similar and may be worth having a contractor CCTV with a lateral launch camera from the mainline. This caused us an SSO."

Results of investigation (continued)

- Lab results
 - Gives chemical composition of substance, but could not specifically identify product
- Leslie Spa and Plumbing Supply
 - Pool repair kits (possible, but unlikely)
- Mission Pools
 - Newer technology of pool finishing (more likely)
- Pool finishing process
 - Interior wall of pool is smoothed by combining a wax/caulk-like substance with water which is then "vacuumed" up in the finalizing process

Possible measures to mitigate?

- Customer outreach:
 - Downstream newsletter article
 - Website notification
- Digs alerts for pools:
 - Contact customer/contractor
- Field Service crews encounter blue substance, have CCTV crew investigate ASAP.
