**MOTION OF THE CALIFORNIA WASTEWATER CLIMATE
CHANGE GROUP TO BECOME A PARTY**

Pursuant to Rules 1.4 and 11.1 of the Commission's Rules of Practice and Procedure, the California Wastewater Climate Change Group (CWCCG) submits its motion to become a party in this proceeding.

CWCCG is an ad hoc association consisting of publicly-owned wastewater agencies in California. Our membership includes the California Association of Sanitation Agencies, the Bay Area Clean Water Agencies, the Central Valley Clean Water Association, and the Southern California Alliance of Publicly-Owned Treatment Works. CWCCG's mission is to address climate change policies, initiatives, and challenges through a unified voice advocating for California wastewater community perspectives. Together, CWCCG treats over 90% of the municipal wastewater in California, including beneficial use of products such as biosolids and biogas. CWCCG's members are in the process of developing and operating renewable generation facilities in conjunction with their wastewater operations.

CWCCG seeks party status for the purpose of filing comments, and possibly reply comments, on the Proposed Decision of Administrative Law Judge Anne E. Simon on Tradable Renewable Energy Credits, issued on December 23, 2009. CWCCG will contend that a TREC

market will help California's wastewater agencies develop renewable energy projects, and this contention is reasonably pertinent to the issues already presented in this proceeding.
